

Invitation for Bids

1. The Letang Municipality has allocated funds towards the cost of Construction of inter religious peace monuments and intends to apply part of the funds to cover eligible payments under the Contract for Construction of inter religious peace monuments (Contract No: LM/MOR/NCB/W/02/2080-81). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Letang Municipality, Morang invites electronic bids from eligible bidders for the construction of Construction of inter religious peace monuments under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:
41,942,000

Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, in at least One (!) Contract within the last ten (10) years, with a value of at least NRs 42542000 that have been successfully or are substantially completed and that are similar to the proposed works.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Letang Municipality, Morang, Letang, Morang, Morang, Province One, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Letang Municipality, Morang, Letang, Morang, Morang, Province One, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a nonrefundable fee of 5000.0 NRs. till 05-11-2023 05:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

7. Sealed or electronic bids must be submitted to the office Letang Municipality, Morang, Letang, Morang, Morang, Province One, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 06-11-2023 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 06-11-2023 13:00 hours at the office of Letang Municipality, Morang

Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1999910 which shall be valid for 30 days beyond the validity period of the bid.
